Please note that the above is only an estimate and overall costs can vary. The above estimate does not include the cost of medical testing and medical procedures. ¹ As set forth in the Agency Agreement for Services, \$3,000.00 of the agency fees to be matched with a donor shall be non-refundable upon a verbal commitment by a donor to work with the intended parents. The remaining \$3,000.00 shall be non-refundable upon the donor successfully completing the screening process at the fertility clinic.

 2 As set forth in the Agreement for Legal Services, the \$1000.00 legal fee for drafting and negotiating the egg donor agreement shall be non-refundable upon the first draft of the agreement being sent to the intended parents.

³ As set forth in the Agreement for Legal Services, the \$500.00 legal fee for the managing of the client trust account shall be non-refundable upon the establishment of the account.

⁴ Your donor will need to be represented by her own independent attorney for the review and negotiation of the egg donor agreement. We will refer your donor to an independent attorney who specializes in reproductive law. The donor's attorney's fees are the responsibility of the Intended Parents.

⁵ The average donor fee is \$7,000.00. However, we do allow donors to set their own requested fee with a maximum allowable fee of \$10,000. The donor's requested fee is noted on her profile in the egg donor database.

⁶ Typical expenses for local donors include mileage, parking, tolls and sometimes transportation to and from the IVF clinic, out of pocket costs for medications, and childcare for attending appointments. Please note that the contract with the egg donor will detail the expenses that the donor will be entitled to. Also, you will receive a detailed accounting of any expenses that were incurred and any funds remaining in the trust account will be refunded to you.

⁷ Donors who do not live within driving distance to the IVF Clinic will incur significantly higher expenses. Typical expenses for distant donors include airfare, hotel and transportation to and from the airports for the screening appointment, airfare, hotel and transportation to and from the airports for the donor and a companion for the retrieval, transportation in the area of the IVF Clinic, and daily meal allowance of \$75.00. In addition, the donor will go to a clinic local to her for the first few monitoring appointments.

⁸ Some IVF Clinics include the cost of the excess health insurance policy in the screening costs. Others do not. Intended Parents should ask their clinic about this cost. If the excess policy is not available through the clinic, the Intended Parents will be required to purchase the excess health insurance policy through our program. The insurance premium is approximately \$400.00.

⁹ The estimated total cost of \$16,400.00 assumes a local donor, receiving a \$7,000.00 fee, having \$1,000.00 in expenses and paying \$400 for the complications insurance. The estimated total cost of \$24,400.00 assumes \an out of area donor, receiving a \$10,000.00 fee, having travel and monitoring expenses of \$6,000.00, and paying \$400 for the complications insurance. These estimated totals will be lower if you choose a donor with a lower requested fee.
